

AN INTRODUCTION TO OUR MINI FREIGHTER

Our Mini Freighter (MF) now offers us additional floor and overhead compartment loading capabilities in the passenger cabin of select aircraft, in addition to our belly hold capacity. The removal of seats from select B777-300ER aircraft means an additional carrying capacity of up to 17.1 tonnes and 106.5 cubic metres (CBM), on top of the existing belly capacity of 40 tonnes and 140 CBM, ensuring we are well placed to serve your needs even better.

Please note that we can only operate to destinations where we have local Civil Aviation Authority approvals for scheduled and charter operations. Our current scheduled route network is available on skycargo.com

LOADING GUIDELINES

With the exception of "General Cargo" only specific commodities which meet certain criteria can be accepted on the main deck passenger cabin of our Mini Freighters.

Can be loaded, but with restrictions



PERISHABLES

- Cut flowers
- Preserved flowers & plants
- Wood / tree products
- Dry and non-strong-smelling fruits & vegetables

PHARMACEUTICALS

- Pharmaceutical shipments containing a data logger can be accepted for cabin loading but only if data loggers have been approved by Emirates SkyCargo in accordance with current procedures. Please contact your local Emirates SkyCargo office for a list of approved data loggers.
- Only pharmaceuticals with a temperature range requirement of 15-25 Degrees Celsius can be accepted for transport in the passenger cabin.

Cargo limitations



THE TRANSPORTATION OF THE FOLLOWING CARGO IN THE CABIN ARE PROHIBITED:

- Dangerous goods
- Mail
- Batteries, including batteries contained in, or packed with, equipment
- Cargo of a piercing, dense, rigid or penetrating nature, or cargo with sharp edges or corners, such as rods, pipes, extrusions or beams, that could become a projectile hazard during flight operations
- Live animals

LOADING GUIDELINES

Cargo limitations



ONLY THE FOLLOWING ITEMS ARE AUTHORISED FOR TRANSPORTATION IN CABIN:

- Electronics / electricals including components, parts and accessories
- Pharmaceuticals and medical devices/equipment/accessories/PPE and parts thereof
- Hardware (metallic, plastic, composite based)
- Food and food items
- Machinery, machines and parts there of
- Clothes, and fabric, leather goods and parts thereof
- Flowers, plants and flora
- Raw Materials (e.g. Rubber, Steel, Wood, pigments and non-DG chemicals)
- Cigarettes and Tobacco products
- Paper wares and printed materials
- Cosmetics
- Relief and Humanitarian Goods
- Personal Effects and household furniture, appliances, toys and accessories
- Sports equipment, parts and accessories

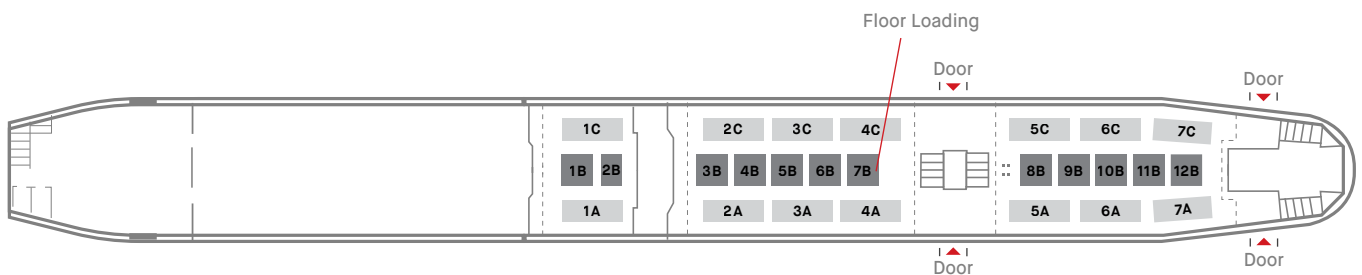

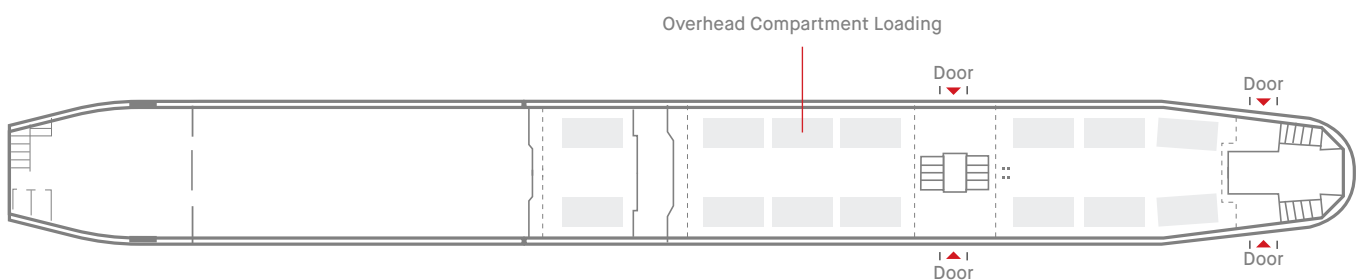


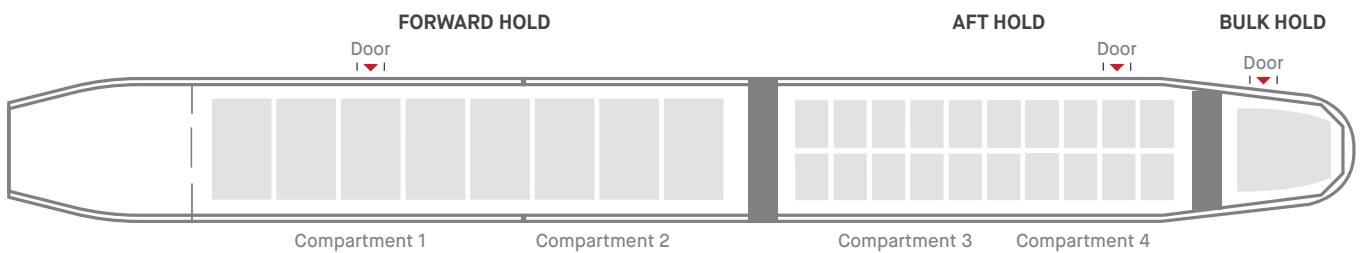
